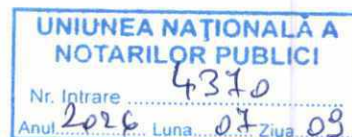

În conformitate cu prevederile art. 5 alin. (1) din OUG nr. 202/2008 privind punerea în aplicare a sancțiunilor internaționale, cu modificările și completările ulterioare, vă transmitem spre publicare actele prin care se instituie/modifică/abrogă regimuri sancționatorii internaționale, pentru postarea lor pe site-ul dvs. și, după caz, pentru comunicarea acestora către entitățile raportoare/membrii dvs., în vederea îndeplinirii obligației de asigurare a publicității.

Astfel, vă informăm că, la data de 8 iulie 2026, Comitetul de sancțiuni aferent regimului de sancțiuni internaționale împotriva ISIL (Da'esh) și Al-Qaida și persoanelor, grupurilor, întreprinderilor și entităților asociate a decis modificarea datelor de identificare a unei persoane listate în cadrul acestui regim. Security Council ISIL (Da'esh) and Al-Qaida Sanctions Committee Amends One Entry to Its Sanctions List

On 8 July 2026, the Security Council Committee pursuant to resolutions 1267 (1999), 1989 (2011) and 2253 (2015) concerning ISIL (Da'esh), Al-Qaida and associated individuals, groups, undertakings and entities enacted the amendments specified with strikethrough and underline in the entry below on its ISIL (Da'esh) and Al-Qaida Sanctions List of individuals and entities subject to the assets freeze, travel ban and arms embargo set out in paragraph 1 of Security Council resolution 2734 (2024), and adopted under Chapter VII of the Charter of the United Nations.
